Permit and Rental Fees

Winter: November 1 - March 14



-The Great Hall -

A deposit of 50% of the agreed upon rental fees will be required to secure a space rental.

Monday - Thursday

Full Day/12 hours	\$1,500/day
Additional Hours	\$125/hour
Partial Day, 2 hour minimum	\$150/hour

Friday - Sunday & Holidays

Full Day/12 hours	\$2,000/day
Additional Hours	\$175/hour
Partial Day, 2 hour minimum	\$200/hour

Map Room (Seats 15 - 20)	\$80/hr, 2 hr minimum

Weekdays, exclusive trail use & use of timing building over 3 hrs	\$1500 with \$250 non-refundable deposit
Weekdays non-exclusive use of trails, over 3 hrs	\$900 with \$250 non-refundable deposit

Cross Country Ski Races

Weekday less than 200 skiers, under 3 hours	\$300 with \$175 non-refundable deposit to reserve
Weekdays, 200 skiers or more, under 3 hours	\$600 with \$175 non-refundable deposit to reserve
Weekdays, natural snow, under 3 hours	\$150 with \$50 non-refundable deposit to reserve
Weekdays after 6p, less than 50 skiers	\$200 with \$50 non-refundable deposit to reserve
Weekdays before Noon	\$1,500 with \$250 non-refundable deposit to reserve

Group Classes

Group of 8 or more, or group of any size conducting classes for a fee	\$25/time slot

Demos/Event Registration

Permit Fee	\$150 per 2 parking spaces or similar size space, up to 4 hr time slot
Entire North Parking Lot	\$1500, up to 4 hr time slot

Mill Valley Restaurant is the caterer of record for The Trailhead, with the right of first refusal for all events. In the event Mill Valley exercises that right, an approved outside caterer may be used, with a fee of 12.25% of the final catering bill payable to The Loppet Foundation to be collected at time of invoicing. The Loppet Foundation will waive the 12.25% fee if an outside caterer is used for cultural considerations.

Any and all alcohol for an event MUST be purchased through Mill Valley Restaurant, regardless of caterer.
